

## **SUMMARY ANNUAL REPORT**

### **For Elara Caring**

This is a summary of the annual report of the Elara Caring, EIN 47-5221330, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BW NHHC Holdco, Inc dba Elara Caring has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with BlueCross BlueShield Of Texas, Metropolitan Life Insurance Company, Continental American Insurance Company, Beazley Insurance Company, Inc., Ameritas Life Insurance Corp., Amalgamated Life Insurance Company, and Lincoln National Life Insurance Company to pay Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$6,305,132.
